• **Software and Systems Implementation**

- Primary focus has been PathNet General Lab including medical device interfaces (MDI) and collections and Microbiology. Building and troubleshooting orders, order entry formats, charting, Autoverification, charge services, PowerChart, label routing and integration issues that arise. Secondary focus has been on PharmNet, CPOE and Meds Integration.
- Building General Laboratory and Microbiology using the bedrock tools as well as the traditional tools
- Alias build to outside EMR's and reference labs
- Migration from Classic PathNet to Millennium PathNet utilizing Cerner Bedrock application and Method M
- Project management of PathNet projects to include all modules
- Project management of the CPOE, Medication Integration and Pharmacy projects for a new facility in a multi-facility system, including documentation of the Project Plan in Microsoft Project, meeting preparation, issue management, system validation, integration and unit testing. Assisted nursing in design, troubleshooting and training of the eMAR tab within PowerChart
- Assisted PharmNet project team for a large multi-facility, multi-Net implementation to identify gaps in Solutions Factory build and resolve outstanding issues in preparation of Integration Testing, Unit Testing, and Conversion

This team is responsible for the successful implementation of Cerner solutions taking control of the installation after the build is completed. The team's involvement begins with integration testing and troubleshooting and then converts the site and provides post-conversion support. Main focus during this time was PathNet Microbiology and General Lab applications. Was also responsible for event code and event set troubleshooting and maintenance.

- Responsible for conversion planning and test script development for various testing cycles (Integration, Unit, Parallel, Regression, etc.)

I also was on the team that brought entire hospital labs up on the Cerner Millennium system from creating Data collection worksheets to build, testing, training and go live in these same multi site domains.
- Worked as Interim Project Manager for a large hospital system responsible for the projects of new Beckman analyzers and new Siemens POC systems. We had approximately 12 Hospitals going at the same time in different stages of build, testing and conversions
- Joined a team to work tickets and assist with projects for a 14 hospital site. They hired 3 new team members and I was responsible from training them on the Millennium system. Two of them had end user Cerner experience, but none of them had any Cerner build experience.

- Was part of a team to build a new academic hospital that was replacing one of the hospitals in a 9-facility site. This included building some new instruments and facilitating the move of some instruments. We added all new service resources, so all had to be added to current orders. The hospital had new floors and rooms, so new service area had to be created and all default routing was to go to the new hospital. Also all collection routes and runs as well as default label printing had to be re-vamped.
- Joined a team to clean up the Microbiology build for a multi-site facility. Including interfacing with Cepheid, Microscan and Bac-T-Alert.
- Worked with a multi-site, Multiple domain organization to install and support General Laboratory and Microbiology. While at this site we standardized approximately 90% of the inhouse order catalog. We were using multiple reference laboratories in the beginning, but later went back and updated system to use one main reference lab.
- Assisted in the build for a new Corelab for a five hospital system. Set up a robotics system that included 5 chemistry analyzers and 2 coagulation analyzers. Also set up Hematology robotics that included 3 analyzers, cell stainer and automated Diff reader.
- Working with General Lab, Microbiology and Blood Bank of a multi-site facility to work with the Cerner Bedrock application for a Migration from Classic to Millennium.
- Served as member of installation team for Cerner Millennium for multi-entity health system. Responsible for the installations of General Laboratory, Collections and Medical Device Interfaces for two hospitals.
- Performed in the lead role in the conversion of seven (7) Cerner PathNet Millennium sites.
